#### 1. What is the research study about?

You are invited to join this study exploring perceptions and experiences of dowry, and where dowry practices might become abusive for women from Indian communities who currently live in Australia. This includes women currently living in Australia who were:

- born in India
- born in Australia with an Indian cultural background
- born in another country with an Indian cultural background

The experience of dowry could have happened in India, Australia, another country, or across many countries.

Examples of dowry abuse can include:

- Ongoing demands for dowry (e.g., money, gifts).
- Pressure to provide expensive gifts or large sums of money as part of dowry.
- Denigrating comments or harassment about the quantity of quality of dowry brought.
- Punishment for "insufficient" dowry.
- Physical, sexual, verbal, emotional or other abuse in retaliation for "insufficient" dowry or for not giving in to demands for dowry.
- Threats to withdraw sponsorship for visa, or actual withdrawal of sponsorship for visa, if dowry is not provided or if the woman does not ask her parents for more money or gifts.

This phase of the study – Phase 2 – involves semi-structured interviews. It explores the lived experiences of women, and the perceptions and experiences of their family and friends. This Participant Information Statement and Consent Form is for Phase 2 only.

Other phases of this project involve:

- an online survey of women from Indian communities currently living in Australia who have experienced dowry abuse, and of their friends and family members who have witnessed dowry abuse (Phase 1); and
- semi-structured interviews with service providers in Australia who support women who experience dowry abuse (Phase 3).

#### 2. Who is conducting this research?

The study is being carried out by:

# 3. Inclusion/Exclusion Criteria

Before you decide to participate in these interviews, we need to ensure that it is ok for you to take part. We are recruiting people who meet the following criteria:

- A. Women who:
  - (a) Are 18 years of age or older.
  - (b) Are currently living in Australia.
  - (c) Have an Indian cultural background.
  - (d) Identify as having experienced dowry abuse.

# OR

- B. Friends or family members of a woman who:
  - (a) Is 18 years of age or older.
  - (b) Is currently living in Australia.
  - (c) Is of an Indian cultural background.
  - (d) Has experienced dowry abuse.

#### AND

Friends and family members must also:

- (a) Be 18 years of age or older.
- (b) Have witnessed the dowry abuse.

You are not eligible to participate in these interviews if you:

- A. are currently at risk of violence, abuse, harm or severe distress from circumstances such as current domestic and family violence and the effects of trauma, current crisis, acute mental illness, or recent suicide attempt/suicidality.
- B. have not separated from the abusive partner and/or are living with family members who are also perpetrator(s) of the abuse.
- C. wish to complete the interview in relation to dowry abuse that is currently ongoing.
- D. are currently experiencing homelessness.
- E. have current involvement in court, tribunal or administrative proceedings related to the abuse or their relationship with a perpetrator(s) (e.g., ongoing child custody, family law, or immigration proceedings).

To participate in the interview over the phone or online via a video conferencing platform you must have access to a safe phone line or safe internet. You can request this interview mode and it may be necessary because of COVID-19 or other restrictions.

# 4. Do I have to take part in this research study?

Participation in this research study is voluntary. If you do not want to take part, you do not have to. If you decide to take part and later change your mind, you are free to withdraw from the study at any stage.

If you decide you want to take part in the research study, you will be asked to:

- Read the information carefully (ask questions if necessary contact details for the research team are available below at Section 11).
- Answer some screening questions to ensure that it is okay for you take part in the study.
- Sign and return the consent form if you decide to participate in the study.
- Take a copy of this form with you to keep.

The screening questions ask questions to make sure that it is okay for you to take part in the study. You will be asked questions about whether you meet the criteria in Section 3 above. Ms Sara Singh will ask you the screening questions over the phone or email. If your answers to the questions show that you meet the criteria to take part in the study, then you will be able to participate. If your answers to the questions show that you cannot take part in the study, then you will not be able to participate.

#### 5. What does participation in this research require, and are there any risks involved?

If you agree to participate you will be asked to:

- Participate in an interview with the Ms Sara Singh for about 90 minutes.
- Have a short phone call with her one week after the interview.
- Read the transcript of the interview and make any changes you would like to make (this is optional).

**Interview:** The interview will be held with the student investigator, Ms Sara Singh, who will ask you questions about your perceptions and experiences of dowry and dowry abuse. This will include questions about:

- If you are sharing your own experience of dowry abuse or someone else's.
- Where the dowry abuse happened (e.g. in Australia, overseas).
- The importance of dowry in the community.
- What you think about dowry as a custom.
- What you feel about the way dowry happens.
- Your experiences and thoughts about the dowry abuse.
- What experiences you or your friend or family member have had in getting support.

If you reside in Sydney and no COVID-19 restrictions exist, you will be given the option for the interviews to take place in-person, via phone or via a video conferencing platform (e.g. Microsoft Teams, Zoom, Skype). However, if you reside outside Sydney and/or there exist COVID-19 restrictions that prevent the Ms Sara Singh from conducting an in-person interviews with you, you will be given the option for the interview to take place either via phone or a video conferencing platform.

You are welcome to bring a support person to the interview with you.

The research team requests your permission:

- To audio record the interview using a digital voice recorder.
- For the Ms Sara Singh to take written notes of the interview as it progresses.
- To share the audio recording of the interview with a professional transcriber. Recordings will only be made available to the transcriber after they have signed a confidentiality agreement with UNSW.

If you do not wish to be audio recorded but would like to participate in the interview, please advise the Ms Sara Singh prior to the interview, and only written notes will be taken.

**<u>Reimbursements</u>**: You will receive a \$30 Westfield voucher to reimburse you for any reasonable travel, parking, or other expenses associated with completing the interview.

**Psychological distress:** You may feel that some of the questions we ask are stressful or upsetting. If you do not wish to answer a question, you can skip it. You can also take a break at any time during the interview or you can stop the interview immediately. If you become distressed as a result of your participation, the research team can provide you with information about support services. A list of contactable support services is also included in Section 11.

**Phone call:** Ms Sara Singh would like to call you seven days after the interview to check that the interview has not caused you any ongoing distress. She will discuss this with you and make a time to call.

**Disclosures about children at risk of harm**: Please note that if you disclose to Ms Sara Singh information about a child or children at current risk of harm due to child abuse or neglect, Ms Sara Singh will share this information with the study's Chief Investigator (Professor Jan Breckenridge) and Co-Investigators (Emeritus Professor Louise Edwards and Adjunct Professor Manjula O'Connor), and will secure their advice about appropriate steps that may need to be taken to address this risk. Professor Jan Breckenridge and Adjunct Professor Manjula O'Connor are designated mandatory reporters who are required by law to report suspected child abuse and neglect to government authorities. Should you make a disclosure about a child or children at current risk of harm due to child abuse or neglect, the research team will work with you to ensure a constructive and inclusive referral process to child protection services if this is assessed from the information provided as being required. We will also provide you with a referral to community or professional services.

<u>Reading the interview transcript</u>: You will be given the option of reading, correcting and editing the transcript from the interview. You can decide to give no feedback or feedback by phone, email, skype or in-person.

#### 6. What are the possible benefits to participation?

We hope this research will benefit people who have experienced dowry abuse. A better understanding of dowry, where dowry became abusive for women from Indian communities, and the types of services

that are available to affected women will help develop better support and improve responses to dowry abuse in Australia.

# 7. What will happen to information about me?

By signing the consent form, you consent to the research team collecting and using information about you for the research study. The interview recording will be transcribed by a professional transcriber who has signed a confidentiality agreement with UNSW or Ms Sara Singh. All transcripts will be deidentified by a member of the research team and stored electronically on a UNSW secure OneDrive to which only members of the research team have access. Primary data will be kept separately from names, consent forms and other personal details.

The research team will store the data collected from you for this research project for a minimum of 7 years after the completion of the research.

Your information will only be used for this research project and will be used in a de-identified way. While de-identified quotes will be used as examples of themes developed from the study, no data will be presented in a case-study format.

- Information collected from you in an electronic format stored on a UNSW password protected OneDrive only accessible to the approved research investigators.
- Information collected from you in hard copy format will be stored in a locked filing cabinet within the Gendered Violence Research Network (GVRN), Level 1, John Goodsell Building, UNSW Sydney, High Street, Kensington 2052 – only the approved research investigators will have access to this information.
- Audio recordings will be stored on a UNSW password protected OneDrive only accessible to the approved research investigators. Audio recordings will also be made available to a professional transcriber. Recordings will only be made available to the transcriber after they have signed a confidentiality agreement with UNSW.

The information you provide is personal information for the purposes of the Privacy and Personal Information Protection Act 1998 (NSW). You have the right of access to personal information held about you by the University, the right to request correction and amendment of it, and the right to make a complaint about a breach of the Information Protection Principles as contained in the PPIP Act. Further information on how the University protects personal information is available in the <u>UNSW</u> Privacy Management Plan.

#### 8. How and when will I find out what the results of the research study are?

The research team intend to publish and/ report the results of the study in a variety of ways including that are publicly available. All Information will be published in a way that will not identify you.

If you decide to leave the research study, the researchers will not collect additional information from you and any information which you have provided for the purpose of this research study will be withdrawn.
